ORGANISER'S REPORT: 31st March 1979 - 1st April 1980

This has been a period of growth and expansion. During the year 2791 people consulted the Bureau by personal visit, telephone, letter or home visit. Most of the enquiries came from the Wokingham district, but there were more far-flung queries, including one by air-mail from Queensland, Australia! A second interview room has been fitted up and is proving invaluable.

Staff and Training

Mrs. Miriam Spiers left to take up full-time work with the Community Service Unit of the Probation Service. We welcome Mrs. Shelagh Rabbett who has completed training and selection, and Mrs. Mary Dodd, formerly of the Reading Bureau.

Volunteers attended day training sessions on Consumer Affairs, Housing, Employment, Marriage Guidance, Bereavement, Family Problems and Marriage Breakdown. Four volunteers attended the residential course in 1979 on Counselling and two the 1980 residential on Consumer Affairs. The Organiser attended the residential course on Effective Helping.

Mr. Robert Boyd is a member of the Southern Area Training Committee and is a tutor for the basic training course on Money Matters. Mr.Boyd also assists clients at the Bureau with financial problems including Income Tax and Insurance. Mrs. Alder is a tutor on Family and Matrimonial problems.

Eleven staff meetings were held and all volunteers attended more than the statutory minimum of six meetings.

Little Court Experiment

In 1979 the Organiser of Little Court Day Centre asked if we would hold monthly sessions at the Centre for the benefit of the elderly and disabled who were unable to come to us, and this was started in November. At present Mrs. Jackie Jones is coping with this single-handed, and considers that it is worth continuing through 1980.

Legal Rota

The rota started in December 1979 and had six sessions by the end of March, and 21 clients were advised on a range of subjects. We are most grateful to the solicitors who give their time and expertise.

Statistics


The summary of enquiries later in this report is divided into 15 categories as used by all Bureaux. The highest category this year is Consumer, which must be largely due to the closure of the Consumer Advice section of the Trading Standards Department. The Bureaux are now the only organisations available in the area giving advice and help to shoppers.

WOKINGHAM CITIZENS ADVICE BUREAU - TREASURER'S REPORT

This year has been the second full financial year since the Bureau first opened in June 1977. That year which ended 31st March 1978 contained many items of expenditure concerned with the setting up of the Bureau and were non-repetitive. It is only this year that the comparative income and expenditure can be of value.

The income remains the same and our grateful thanks go to our 'regular' Grants and Donations without whose help we could not function. They respond to our letters of appeal, although some three hundred requests fall on stony ground.

The high figure of interest is attributable to keeping the maximum amount of our monies on Doposit Account whilst interest rates are high; but it is doubted whether the interest rates or the amount on deposit will be so high again.

The sundry income is derived from proceeds of the C.A.B. stall at the annual Wokingham Carnival; small token donations made anonymously to the Bureau Collecting Box, and in response to a talk by the Organiser.

The expenditure has been kept to a remarkably tolerable level despite growing inflation and thanks must go to the careful control of the Bureau Staff. The only unbudgeted item was a Water Rate demand covering the period from inception of the Eureau to date. This has been paid in full but remains the subject of discussion with the Hid Southern Water Co. The principle of Water Rates is correct as the water company do not allow any relief to voluntary organisations in the same manner as the relief that can be obtained on the General Rate.

The conclusion of this financial year is a deficit of £288.04 with the following bills falling due for payment within the period, but settled immediately after:-

If these items are added to our loss of £288.04, our total expenditure exceeds our income by £460.45; a poor but necessary result. It was fortunate that our reserves were able to bear this deficit, but it is imperative that the situation does not occur again.

Finally the Accounts do not reflect the full 100% Rates Relief that the Wokingham District Council allow us, nor the true rent of the Bureau offices for which the Wokingham Town Council only charge a peppercorn rent of £1, and neither the generous building works provided by Luff Building Limited either free or at a fraction of the true cost. A grateful thank you to all three.
