All through this year we have been planning for the Bureau to extend its services into Woodley. A number of people have wondered why we are doing this when we have had comparatively few known enquiries from that area - 110 last year and 163 this year. That, paradoxically, is the reason; Woodley is part of Wokingham District, and yet when the residents want to consult a CAB, they go to Reading. This is not as it should be, Wokingham should serve its own people. It is interesting to note that in the first six months of this year we had 52 enquiries from Woodley; then there was an article in the Woodley Chronicle about our scheme, followed by an item in the Town Council newsletter, and during the last part of the year we had more than twice as many enquiries as in the first half. Perhaps Woodley people are beginning to realise that our services are for them as well.

The Bureau is now operating to capacity at times in its Town Hall office, and I think we shall soon reach the limit of the number of people we can properly assist in one session. As usual the largest number of enquiries in one category was in Consumer, Trade and Business (1201), followed by Family and Personal (914), but the biggest increase was in Employment problems, which went up by 221 queries to a total of 821.

## TALKS

I have given talks to Pinewood Circle, the Earley Active Retired Group, the Over-60's Clinics at Finchampstead, the Civil Service Retirement Fellowship, the Woosehill Ladies Club, and the West Forest T G Activity Group.

### TREASURER'S REPORT

This year has seen expenditure exceeding income once more though with generally rising prices, and income only £190 more than in the previous year, this was not unexpected. At the same time there has been another sharp increase in the number of enquiries, with the result that the cost per enquiry has actually reduced to less than 62p.

We are most grateful to all those who have supported us with financial help during the year, particularly to the Town Council for giving us the use of the Bureau rooms at a peppercorn rent, to the District Council for allowing us 100% rate relief, and to both for their generous grants.

Details of grants and donations received are given on the following page.

During the year it was agreed by the Management Committee that honoraria paid to the Organiser and to her Deputy should be increased in recognition of the efforts and many hours given by both to the work of the Bureau. This accounts for most of the increase of bureau expenditure and my thanks are due to all the bureau staff for containing other costs so well in spite of the constantly increasing pressure upon them.

## STAFF AND TRAINING

I would like to remind all who read this that all the workers, apart from myself and my deputy, are entirely voluntary, and receive no remuneration for the many hours of hard work that they give to the bureau and the community. They receive a small travel allowance if they use their cars or public transport for bureau duties or to go on training. All volunteers work for a minimum of one session of 4 hours per week while we are open to the public, and then have to complete their paper-work before they go home. They attend one staff meeting per month, and various training sessions. Visits are made to the homes of those too elderly or infirm to come to the office. Without these trained, dedicated voluntary workers the bureau would cease to exist, and I am both proud of and grateful to them.

The deputy Organiser, who receives £850 per year, does at least 10 hours duty each week, and some of the administration and in-bureau training, as well as the normal attendance at meetings and training for all workers. I receive £1500 per year, and spend an average of 15 hours per week on bureau work, which includes interviewing, administration, training, attendance at local and area meetings, giving talks, and making outside visits. I mention this simply in order to show what a cost-effective service is given in Wokingham.

We were all shocked and saddened by the loss of Mr Gordon Robins last September. He was a valued member of staff and is much missed.

Mrs Clare Odds has been appointed Organiser of Yateley CAB. She will be sorely missed, but we wish her well in her new duties. We now number two Organisers and a Deputy among our ex-workers!

Training has been given on Debt, Consumer Problems, Marital Breakdown, and Multiple problems. Five workers have attended the Basic Training Part II, and the Deputy went to the residential course on In-Bureau Training. Four trainees have completed three months training in the Bureau and the 9-week Basic Training Part I.

All workers have attended the required minimum of six staff meetings, and most have been to far more. Two members of the Management went on the Course "The Management Committee as Employers".

## SPECIALIST ADVICE

54 people were advised at the Solicitors' Rota sessions. We are again most grateful to the solicitors who give their time and advice free of charge. Mr Boyd has given financial advice to 91 clients by appointment, and to many others who came in without prior notice. This is also an entirely voluntary service.

#### THANKS

Our most grateful thanks are due to all who have helped us, in cash or in kind.

I would also like to thank the Management Committee, and especially the officers, for their help and support during the year.

## CAR PARKING

Minutes of the Annual General Meeting, held on Wednesday June 27th 1984.

MINUTES of the last AGM were accepted as a correct record.

CHAIRMAN'S REPORT: In presenting his report, the Chairman pointed out that enquiries dealt with were increasing in complexity as well as in number. The prospects of opening an extension in Woodley were good, and it should relieve pressure on the Reading bureau. Woodley Town Council had promised financial support. Turning to the financial position generally, it had to be kept in mind that NACAB policy was to pay Organisers and Deputies on local government scales. Resources were by no means adequate to reach that level, so there was no room for complacency. He expressed his gratitude to the retiring Secretary, and to the Treasurer, who announced his intention of resigning as soon as a replacement could be found.

In reply to a questioner from the floor, who doubted the wisdom of NACAB'S salary policy, the Chairman stated that the cost of implementing it would be approximately £6,900 p.a. plus National Insurance.

TREASURER'S REPORT: In presenting his report, the Treasurer drew attention to the very welcome increase in the volume of donations. Our gratitude was especially due to the local authorities which gave their financial support. Although the balance was slightly down on last year, he thought that the accounts showed that the bureau provided excellent value for money.

Mr H R Wells offered parking for the cars of two volunteers in his drive, which was located conveniently close to the bureau, as a means of keeping down one item of costs.

ORGANISER'S REPORT: In presenting her report, the Organiser referred to the Lovelock report which had appeared during the course of the year and which had vindicated the work of the bureau nationally in a resounding way.

Volunteers were being taken on to train for the Woodley branch, which would open one day a week to begin with.
